CANCELLATION POLICY

Crabtowne Skiers, Inc. is a not-for-profit organization that arranges trips and activities for the enjoyment of its member/guests. All member/guests and nonmembers must conduct themselves in accordance with the club policies. All participants must be current Crabtowne Skiers Inc. club members or the guest of a member. Payment for guests must be on members check or a participant may be a Blue Ridge Ski Council affiliated club member. Non-members add fee to cost or join club, \$40.00.

CSI Cancellation/Refund Policy: If a participant of a CSI event withdraws from the event, the CSI will refund any monies prepaid by participant that CSI is able to recover from the events vendor/contractor, less cancellation fee (15% of cost up to \$30.00). All vendor/contractors cancellation policies apply first, and then the Standard Club Policy applies. Refunds will not be made until after the event is completed and all financial transactions are completed with the club treasurer. All fees and monies remaining from each cancellation are the property of the club and may not be spent by the Trip Leader. Any replacements must be eligible to participate in the event under the rules of the CSI, and must be taken in order from the wait list. If CSI cancels an activity, refunds will be distributed from available funds from that activity. Specific prepayment requirements and cancellation penalties will vary with each event.

Trip deposit check and signature on application AND signature on Waiver (below) must accompany this application. This application may be completed at a General Meeting or sent in the US mail. No application may be e-mailed or faxed. Applicants will be placed on the sign-up sheet as received by leader and a wait list will be established as necessary.
